A.) Current specialty certification in Obstetrics & Gynecology from ABOG or AOBOG

B.) Board eligibility in Obstetrics & Gynecology in accordance with UCSF Bylaws timelines or foreign training leading to board equivalency.

Renewal Criteria:

1. Participation in Maintenance of Certification in current specialty/subspecialty certification in Obstetrics & Gynecology from ABOG or AOBOG

2. Activity levels as outlined in specific privileged below

Practitioners who do not meet the activity levels for maintenance/renewal criteria (such as Courtesy appointee) for particular privileges may submit – from their primary practice location—either;

A.) A peer reference from the service Chief or Chair attesting to clinical competence in the requested privileges, or

B.) Case-logs of clinical activity from their primary practice location (ZSFGH).

Category 1 - Basic Privileges Patient management, including H & Ps and diagnostic and therapeutic treatments, procedures and interventions to admit, evaluate, treat, and provide consultation to adolescent and adult female patients and/or provide medical and surgical care of the female reproductive system and associated disorders, including major medical diseases that are complicating factors in pregnancy. May provide care to patients in the intensive care setting in conformance with unit policies. Assess, stabilize, and determine the disposition of patients with emergent conditions consistent with medical staff policy regarding emergency and consultative call services.
